PROPOSALS

Each member organization, with the exception of Contact Members has the opportunity to submit proposals to be included in the Agenda 2011, providing their dues are up to date and they are a member in good standing. Individuals may only submit proposals through their National Federation. However, changes to the Dance Sport Rules must be made through the proper committee, prior to being submitted to

the AGM. Please understand that proposals not submitted by the deadline and included in the official agenda will not be accepted from the floor during the AGM, unless unanimously agreed by the grand body.

All proposals will be published at the IDO website, www.ido-dance.com no later than May 1, 2011. Amendments to those proposals will be accepted no later than May 15, 2011, and the final agenda will be published no later than the first week in June.

The deadline for submitting all proposals is March 15, 2011, to ensure them to be circulated to all members for counterproposals

ELECTIONS 2011

During the AGM 2010, staggered elections have taken place by which the President (Mr. Bill Fowler), the VP New Ventures (Mr. Andrey Kokoulin) and the VP Internal PR (Mr. Peter Szanto) have been elected for a 1-year term ending at the AGM 2011.

Under the staggered system, these 3 positions are up for election in 2011, each for a 3-year term.

All IDO members, with the exception of Contact Members, are hereby given the opportunity to nominate candidates for each position. Nominations should reach the President no later than March 15, 2011, in order to be included in the agenda of the AGM 2011.

Notice is given that the present Senior Vice President (Mr. Jorn Storbraten) has announced his candidacy for President. If elected as President, Mr. Storbraten will resign from office as Senior Vice President. In this case, a new Senior Vice President will be elected for the remaining term (1 year) of Mr. Storbraten. Members are hereby asked for nominations for the office of Senior Vice President (1year) in case Mr. Storbraten is elected as president.

Notice is further given, that there is a strong possibility that one of the Vice Presidents will seek the position of Senior Vice President, if Mr. Storbraten is elected as President. Also, one of the Vice Presidents whose term ends in 2011 may decide not to seek re-election. For these cases nominations will be accepted to fill these "at large" seats. Deadline for all nominations, including "at large" seats, is March 15, 2011 to be sure the Agenda will be finalized in a timely manner.

DELEGATE REGISTRATION FORM

April 1, 2011 - Attached you will find a Delegate Registration Form, which must be filled out and emailed back to me: president@ido-dance.co by April 15, 2011, in order for the Presidium to check credentials and voting status. This also guarantees that unauthorized delegates cannot attend and vote unless authorized by their National Federation. Although Contact members may attend this meeting and speak as allowed by Robert's Rules of Order, they must still submit a delegate registration form, but will not be allowed to vote.

OFFICERS, DIRECTORS, CHAIRMAN AND COMMITTEE REPORTS

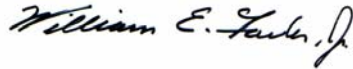

This will allow all member nations to discuss these various reports, along with their recommendations, prior to being voted on. Limited discussion will be allowed on all items included in all reports.

NOTE TO PRESENT PRESIDUM MEMBERS: If your report has any recommendations, etc., they must first be passed by the Presidium to be included in the agenda of the AGM, so it is wise to have your reports to me no later than March 15, 2011, so they can be included in the Presidium agenda for April 8, 2011.
