DEADLINES

March 15, 2010 – All proposals to be included in the Agenda of AGM 2010.

NOTE: Each member organization has the opportunity to submit proposals to be included in the Agenda 2010, providing their dues are up to date and they are a member in good standing. Individuals may only submit proposals through their National Federation. However, changes to the Dance Sport Rules must be made through the proper committee, prior to being submitted to the AGM. Please understand that proposals not submitted by the deadline and included in the official agenda will not be accepted from the floor during the AGM, unless unanimously agreed by the grand body.

All proposals will be published at the IDO website, www.ido-dance.com no later than May 1, 2010. Amendments to those proposals will be accepted no later than May 15, 2010, and the final agenda will be published no later than the first week in June.

This deadline will be strictly enforced to be sure the Agenda will be finalized in a timely manner.

March 15, 2010 - All nominations for candidates for Presidium 2010.

NOTE: As passed at AGM 2009, and by a majority of the Presidium, Riesa, Germany, November 30, 2009, elections 2010 will be conducted in the following manner:

One year term: President, Technical Director, New Ventures Director

Two year term: Senior Vice President, Internal PR, DIES and Judges Registration

Three year term: Executive Secretary, Competition Director, Adjudication Director.

To date, all present Presidium members will be seeking re-election to their present office.

Nominations for all positions will be accepted until March 15, 2009, and no nominations will be accepted from the floor. Nominees must accept or reject nominations just prior to the elections.

This deadline will be strictly enforced to be sure the Agenda will be finalized in a timely manner

OFFICERS, DIRECTORS, CHAIRMAN AND COMMITTEE REPORTS


