## AGM 2006 – report Competiton Committee

Since January 1, 2006 the “new” IDO-logo has been implemented by the IDO officially.

Within the year 2006 the “old” Logo should be exchanged by the “new” one.

In 2007 and afterwards only the “new” logo should be used.

The “new” logo can be downloaded from the secured member–site [www.ido-dance.com](http://www.ido-dance.com) by the national federations or the contracted organizers only.

The new IDO-Logo ALWAYS has to be printed on a white ground and the two colours: red and blue.

**It can not be changed in any way.**

The following people and institutions may use the IDO-logo:

**All IDO-officials representing the IDO for IDO-business (only):**

- Official IDO members (federations/ countries in conjunctions with the sentence: Member of the \_\_\_\_\_
- IDO-contacts in conjunction with the sentence “Contact of the \_\_\_\_\_”

*As long as the contact is valid:*

1. Members of the IDO presidium
2. IDO-directors
3. Regional Chairmen / -ladies
4. Chairmen / -ladies of the IDO Committees and Subcommittees
5. IDO-Officials for IDO-press releases and press contacts
6. People appointed by the IDO-presidium to represent the IDO

7. All Organizers in conjunction with the publifications for the IDO-contracted events.
  - Invitations / letterheads  
you can buy IDO-stationary for lists – contact Peter and Balazs

  - Posters / handouts / flyers
  - Diplomas / certificates  
you can buy IDO-Diplomas – contact Peter and Balazs
  - Cups / trophies / medals
  - Start- and result-lists  
you can buy IDO-stationary for lists – contact Peter and Balazs
  - Information about the event  
you can buy IDO-stationary for lists – contact Peter and Balazs

**No one else may be using the IDO-Logo without written permission from the IDO-President!**

Here are some examples which have been seen and are not allowed any more:

- Private IDO-related persons hold (mostly the old) IDO logo on their business cards or other media (internet)
- IDO-judges / IDO-choreographers / IDO teachers etc. for any publifications including business cards
- Dance studios, clubs, schools or other institutions etc. for any publification including business cards, flyers, posters etc.
- Actually for anybody who is not among the people 1 – 7 above.

***Time to change the “old” logo into the “new” one:***

People who already have used the “old” or “new” IDO-logo on their private or business cards, their schools, studios etc. have to make sure not to use them after December 31, 2006 – otherwise they might loose the status of the Registration.

### How to state / show you are related to the IDO

- Dance studios, clubs, schools or other institutions who are members of the national IDO-federations and have at least 3 dancers participated at any IDO event can obtain the **official IDO-plaque** for a fee.

## How to state / show you are related to the IDO

- IDO-judges / IDO-choreographers / IDO teachers who want to show their connection towards the IDO may formulate in words - as follows -
  - IDO organizer (if they have a valid IDO-event-contract)
  - IDO registered judge (if they hold a valid IDO-judges license)
  - IDO registered scruteneer (if they hold a valid IDO-scruteneer license)

**Please be aware: the IDO-logo itself may not be used in any of these matters or conjunctions.**



## AGM 2006 – report Competition Committee

---

### Merchandise

The IDO intends to grant the merchandise rights to a private company to get money for IDO business. Therefore nobody is allowed to use the IDO logo on any merchandise unless holding a written permission by the IDO-president.

The IDO-lawyer in Denmark is just checking the tax problems and solutions if the IDO has to found a new company or if it can be done inside the IDO.

If a new company has to be founded, it will be a direct “daughter” of the IDO, directed by a board of three members of the presidium.

The details have to be found out and negotiated.



## ***How can a National IDO-Federation use the IDO-Logo?***

IDO-member-federations who have their own name, like ARDO, CMTO, FIDS or TAF etc. will use their logos for their purposes unchanged – same as before.

IDO-Members who have their country's name in conjunction with IDO – like

- IDO-Estonia
- IDO-India
- IDO-Ireland
- IDO-Lebanon
- IDO Turkey
- etc -

have the following new option:



## ***How can a National IDO-Federation use the IDO-Logo?***

IDO-member federation may use the IDO-logo in the following matter:

**IDO Estonia**

See paper charts.

In this case the national logo will loose the wording “International Dance Organization” and will add the country’s name.

Expenses only 150 € (flat fee) per Logo to be used according IDO-rules as long as the country is a member of the IDO.

Official IDO-member-federations who have the 3 IDO-letters in their name can obtain this official Logo for their country, as shown on the paper chart and may use the “country-logo” as they wish but must follow the IDO-logo-rules above.

→ They may not give this logo to anybody who will use it for private or business purpose, but they may give it to their national officials, judges, scruteneers, representatives etc.

→ A national IDO-logo may in no case be used in any merchandise business or actions.

→ These logos of a national-federation may also only be printed in colors on a white ground. They may not be changed in any way without written permission by the IDO-President.

## **Enlargement member area, new user groups**

- The aim is to ease the national enrolment of large numbers of dancers for the IDO-federations:

## **Enlargement member area, new user groups**

- Every nation has the possibility to set up own national users (clubs/studios/schools ) with limited rights.
- These national users have the possibility to enrol up their **own** dancers/dancer groups.
- These dancers must be part of the nation which has set up as a user.

- These new user groups (within a federation) can only administrate **their** dancers / groups, etc. which have been set up by themselves.
- They may not execute any registrations at competitions, which is still done by the federation itself, to hold the control.

The IDO-competition Committee is helping and assisting other countries to become a member of the IDO or solving internal problems

### *Countries*

- **France** – different dance sport federations, who want to become IDO members → start after the AGM
- **Ireland** – getting one federation to become a member of the IDO-Ireland → solved (!)
- **United Kingdom / England** → to form an “IDO-board” and send dancers to IDO events → solved (!)
- **Ukraine** → problems with two federation → under negotiations
- **Poland** → problems with three federations → solved 😊
